**Applicant Eligibility:**

- Applicants must be currently enrolled in their quest for a nursing, a medical degree or a degree in any other health related field, or to further their education in any other health related field.
- Priority will be given to individuals who will practice at Pana Community Hospital.
- Scholarship winners are encouraged to repay their scholarship for future award winners.

**Criteria for Selection:**

- Board of Directors shall determine the amount, the number of persons receiving the scholarship and the terms and conditions of the scholarship.

**Procedure for Selection:** Applications are submitted to Pana Community Hospital Board of Directors and considered by the award committee. **Professional Letters of Recommendation**

Provide at least two letters of recommendation to evaluate the applicant in terms of character, leadership, personal initiative, work habits, as well as any other attributes you feel may help them to achieve success in their future. One letter should be from a past or present teacher and one non-teacher, to be completed by a priest, minister, employer, family friend, etc.

**Assemble the application in the following order:**

1. Application and Federal Income Tax form 1040 (first 2 pages only)
2. Professional Letters of Recommendation (2 or more)
3. Essay (maximum 500 words) and completed activity sheet
4. **Official Transcripts (must be in a sealed envelope)** and mailed directly to Peoples Bank & Trust
5. Financial Aid award letter, from College/University attending

All of the above information must be provided in order the scholarship committee to consider your application.
